SUBJECT: 2014 CALPERS BOARD OF ADMINISTRATION PUBLIC AGENCY MEMBER ELECTION MATERIAL

Thank you for your help in the upcoming CalPERS Board Election process. It is important the Agency Election Officer reviews the enclosed 2014 election material and follows all instructions to help facilitate this election process.

ENCLOSED IS THE FOLLOWING ELECTION MATERIAL:

- Instructions To The Agency Election Officer
- Certificate of Delivery, due completed to CalPERS by September 12, 2014
- Employer Report of CalPERS Eligible Voters, for election reference only
- If applicable, a ballot package for prompt delivery to each identified member for whom CalPERS had no address or the address was determined to be invalid

A ballot package containing an official ballot, candidate statement booklet, and return envelope, will be mailed on August 29, 2014, to eligible active members for voting in the 2014 election. Voted ballots must be received by CaIPERS in the postage paid envelope no later than the voting deadline of September 29, 2014. The member must sign the reverse side of the envelope or the envelope will be invalid and the vote will not be counted. If the member loses their return envelope, they can use their own envelope to mail their ballot, by following the instructions in the candidate statement booklet.

INSTRUCTIONS TO THE AGENCY ELECTION OFFICER

As the designated Agency Election Officer for your agency, you are acting as an agent of the California Public Employees' Retirement System (CalPERS). Please read and follow the CalPERS instructions carefully and ensure all your actions are compatible with ethical election practices.

INFORMATION	CalPERS public agency members active as of July 1, 2014, are eligible to vote in this election.				
	On August 29, 2014, CalPERS mailed a ballot package directly to each eligible active public agency member's residential address.				
	Any eligible member who does not receive a ballot package by September 12, 2014, and desires to vote, should contact the Board Election Office immediately at (916) 795-3952, local, or (800) 794-2297, toll free.				
EMPLOYER REPORT OF CALPERS ELIGIBLE VOTERS	The enclosed report shows, in alphabetical order, the names and birth years of the CalPERS members in your agency who are eligible to vote in this election. The information on the report is confidential and is to be used only by the employer as election reference information and not for any other purpose.				
BALLOT PACKAGE DELIVERY TO IDENTIFIED MEMBERS	 If you received any undeliverable ballot packages in this mailing, please: Deliver them to the member whose name is shown on the package Advise each member to whom you gave a package that they are responsible for mailing their own envelope, containing the voted official ballot, to the address shown on the return envelope Do not collect and mail the ballot for the member 				
	IMPORTANT NOTE: The timeframe in which members can vote is short. If you receive any ballot packages, it is essential that you distribute these packages to the identified members no later than September 12, 2014, in order to allow these members the opportunity to return their voted ballots to CaIPERS before the voting deadline date of September 29, 2014.				
	You are responsible for delivering only the material from CalPERS. Enclosure of any campaign material, or material endorsing any candidate, is contrary to the duty of the Agency Election Officer in conducting a fair and impartial election.				
NO BALLOT PACKAGES SENT TO YOUR AGENCY	It is possible that no ballot packages are sent to your agency. This is because CaIPERS had current address information for all eligible members in your agency.				

RETURN A BALLOT PACKAGE TO CALPERS YOU CANNOT REASONABLY DELIVER	It is possible that you cannot reasonably deliver a ballot package to the identified member because the member no longer works for your agency or retired from your agency.
