**Subject: 2020 Open Enrollment Dates and Information**

### Purpose

The purpose of this Circular Letter is to inform you of important dates for 2020 Open Enrollment as well as upcoming open enrollment events and information. This Circular Letter will also explain how to sign up for Employer Bulletins which help you stay informed on CalPERS news and events.

### 2020 Open Enrollment Dates

The following are key dates for 2020 Open Enrollment:

- Your employees' Health Plan Statements will be available in their myCalPERS accounts on **September 14, 2020**. The Health Plan Statement provides an overview of their current health coverage and enrolled dependents.
- The 2020 Open Enrollment will take place **September 21 – October 16, 2020**. During this time, your employees can enroll, change health plans, add eligible dependents, delete dependents, or cancel coverage. Your employees are responsible for providing you any necessary documentation to determine their dependents' eligibility for health coverage.
- The deadline for processing all 2020 Open Enrollment transactions is **11:59 p.m. PT on Friday, November 13, 2020**. Changes made during open enrollment take effect January 1, 2021.

## Employer Webinar

This year, we will be hosting a webinar to provide an overview of health plan changes, guide you on where to find important open enrollment information, and answer your questions. The webinar will be held on August 27, 2020. Registration information will be provided through emails as well as the Employer Bulletin.
