Subject: 2021 Open Enrollment Dates and Information

#### **Purpose**

The purpose of this Circular Letter is to inform you of important dates for 2021 Open Enrollment as well as upcoming Open Enrollment events and information. This Circular Letter also explains how to sign up for Employer Bulletins so you can stay informed of CalPERS news and events.

## **2021 Open Enrollment Dates**

The following are key dates for 2021 Open Enrollment:

- Your employees' Health Plan Statements will be available in their myCalPERS accounts on September 13, 2021. The Health Plan Statement provides an overview of their health premiums for 2021 and 2022 if they don't change plans or enroll dependents.
- Open Enrollment is September 20 October 15, 2021. During this time, your employees
  can enroll, change health plans, add eligible dependents, delete dependents, or cancel
  coverage. Your employees are responsible for providing you any necessary documentation
  to determine their dependents' eligibility for health coverage.
- The deadline for processing all Open Enrollment transactions is **11:59 p.m. PT on Friday**, **November 5, 2021.** Changes made during Open Enrollment take effect January 1, 2022.

#### **Employer Webinar**

Similar to last year, we will host a webinar to provide an overview of 2022 health plan changes, guide you on where to find important Open Enrollment information, and answer any questions you may have. The webinar will be held on September 2, 2021. Registration information will be provided through emails and an Employer Bulletin.

## **Open Enrollment for Employers Webpage**

Prior to Open Enrollment, the <u>Open Enrollment for Employers</u> page will be updated with information regarding:

- Open Enrollment health fairs (available virtually again this year)
- Health plan and benefit changes for 2022
- Health program highlights, employer roles and responsibilities, and Open Enrollment resources

View <u>2022 Health Plan Changes</u> for details on health plans, service areas, and benefit design changes for next year.

#### **Member Communications**

In July, we'll notify members via email of the Preferred Provider Organization (PPO) plan changes and new Health Maintenance Organization plan options. In August, as we have done in previous years, we'll begin sending targeted letters to members impacted by premium increases over 10%, benefit design changes, and PPO plan changes so they're well informed prior to Open Enrollment. We'll provide you with an overview of the letters via the CalPERS website.
