Dear Participant Name,

In advance of the 2023 Health Open Enrollment period, we want to inform you of key changes to your current health plan. Effective January 1, 2024, the total monthly premium for *Health Plan Name* will increase by *Percent Increase*. **If you would like to remain enrolled in your current health plan, no action is required on your part.** 

Please note your share may increase by a different percentage due to your employer's contribution amount. Contact your employer to find out how much they contribute toward your total monthly premium.

We recognize this increase is significant and encourage you to shop health plans. We offer you a variety of plans with quality health care provider networks that may have a lower premium. Some members in your region may save more than \$500 per month by changing health plans, and families may save more than \$1,300 per month. Cost savings projection is based on the single-party rate of the lowest to highest cost plan in the region. Actual savings will vary based on plan, party rate, and employer contribution.

We'd also like to inform you of health plan expansions that may be available in your area for 2024. The expansions include combination plans.

Blue Shield Access+ EPO will be expanding into Del Norte and San Benito counties.

**UnitedHealthcare SignatureValue Alliance** will be expanding into 12 counties for public agency and school members: Alameda, Contra Costa, Marin, Merced, San Francisco, San Joaquin, San Mateo, Santa Clara, Santa Cruz, Solano, Sonoma, and Stanislaus.

**UnitedHealthcare SignatureValue Harmony** will be expanding into Santa Clara and Santa Cruz counties.

Open Enrollment is September 18 – October 13, 2023. Beginning September 11, 2023, you can access your customized Open Enrollment information, tools, and resources online at **my.calpers.ca.gov**.

When shopping for health plans, consider lower-cost options, available doctors and hospitals, and the location of care facilities. We want you to be well-informed so you can make the best decision for you and your family.

**See how much you could save by switching plans.** On September 11, log in to your myCalPERS account at **my.calpers.ca.gov**. Use the **Search Health Plans** tool to:

- Find and compare 2024 health plans available in your area
- See monthly premiums and member satisfaction ratings
- View side-by-side health plan, benefit, and copay comparisons
- Check which plans your doctor or medical group is available in. You may be able to switch to a lower-cost plan and still keep your doctor or medical group.
