Who is a Covered Person?

- Anyone who may have access to material non-public information
 - Board Members
 - CalPERS Executives
 - Office of Enterprise Risk Management (All)
 - Investment Office (All)
 - Fiscal Services (Selected Units & Positions)
 - Office of Audit Services (Selected Units & Positions)
 - Benefit Program Policy & Planning (Selected Units & Positions)
 - Information Technology Services Branch (Selected Positions)
 - Legal Office (Selected Positions)
 - Contracts & Procurement (Selected Units & Positions)
 - Those who provide administrative support to those identified (above)
 - The spouse or registered domestic partner of Covered Person Employees and Board Members



Covered Accounts

A Covered Account is an account where a Covered Person has the ability to place trades or direct trades.



Non-Covered Accounts

A Non-Covered Account is one where a Covered Person does not have the ability to place or direct trades.

Annual Attestations & Certifications

Upon implementation and annually thereafter, Covered Persons are required to complete the following attestations and certifications:

- 1. Personal Trading Regulation
- 2. Covered Account Validation
- 3. Account Statement & Confirmation Authorization



Pre-clearance Requests

- Publicly Traded Securities
- Non-publicly Traded Securities
 - Private Equity
 - Commercial Real Estate



Transaction Denials & Reconsideration Requests

- Transaction Denials
 - Restricted List
 - Holding Period Restriction (30 days)
 - Blackout Period Restriction (day-before, day-of, day-after)
- Reconsideration Requests
