Item Name: Proposed Decision – In the Matter of the Appeal of the Cancellation of the Application for Industrial Disability Retirement of FRANK PERDOMO, Respondent, and CALIFORNIA STATE PRISON, CENTINELA, CALIFORNIA DEPARTMENT OF CORRECTIONS AND REHABILITATION, Respondent.

Procedural Summary

On January 19, 2021, Respondent California State Prison, Centinela, California Department of Corrections and Rehabilitation (Respondent CDCR) served Respondent with a Notice of Adverse Action (NOAA) terminating his employment effective January 26, 2021, due to positive drug test results for amphetamine and methamphetamine. On January 22, 2021, Respondent resigned from his position as a Correctional Officer.

On August 18, 2021, Respondent applied for industrial disability retirement based on orthopedic and psychological conditions. On October 26, 2021, CalPERS determined that Respondent was ineligible for industrial disability retirement pursuant to the legal precedents set forth in *Haywood v. American River Fire Protection District* and its progeny. Respondent appealed this determination, and the matter was heard by the Office of Administrative Hearings on December 1, 2022. Due to Respondent CDCR's failure to appear, the case proceeded as a default under Government Code section 11520 as to Respondent CDCR only. A Proposed Decision was issued on December 21, 2022, affirming CalPERS' determination and denying Respondent's appeal.

Alternatives

- A. For use if the Board decides to modify and adopt the Proposed Decision as its own Decision:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, pursuant to Government Code section 11517 (c)(2)(C) which authorizes the Board to "make technical or other minor changes in the proposed decision," hereby modifies the Proposed Decision, by changing "at CSP" to "at CDCR" on page 3, paragraph 5 and changing "CSP" to "CDCR" on page 4, paragraphs 5 and 7 of the Proposed Decision, and hereby adopts as its own Decision the Proposed Decision dated December 21, 2022, as modified, concerning the appeal of Frank Perdomo; RESOLVED FURTHER that this Board Decision shall be effective 30 days following mailing of the Decision.

- B. For use if the Board decides to adopt the Proposed Decision as its own Decision:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System hereby adopts as its own Decision the Proposed Decision dated December 21, 2022, concerning the appeal of Frank Perdomo; RESOLVED FURTHER that this Board Decision shall be effective 30 days following mailing of the Decision.

- C. For use if the Board decides not to adopt the Proposed Decision, and to decide the case upon the record:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated December 21, 2022, concerning the appeal of Frank Perdomo, hereby rejects the Proposed Decision and determines to decide the matter itself, based upon the record produced before the Administrative Law Judge and such additional evidence and arguments that are presented by the parties and accepted by the Board; RESOLVED FURTHER that the Board's Decision shall be made after notice is given to all parties.

- D. For use if the Board decides to remand the matter back to the Office of Administrative Hearings for the taking of further evidence:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated December 21, 2022, concerning the appeal of Frank Perdomo, hereby rejects the Proposed Decision and refers the matter back to the Administrative Law Judge for the taking of additional evidence as specified by the Board at its meeting.

- E. Precedential Nature of Decision (two alternatives; either may be used):

1. For use if the Board wants further argument on the issue of whether to designate its Decision as precedential:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System requests the parties in the matter concerning the appeal of Frank Perdomo, as well as interested parties, to submit written argument regarding whether the Board's Decision in this matter should be designated as precedential, and that

the Board will consider the issue whether to designate its Decision as precedential at a time to be determined.

2. For use if the Board decides to designate its Decision as precedential, without further argument from the parties.

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, hereby designates as precedential its Decision concerning the appeal of Frank Perdomo.
