In advance of the 2024 Health Open Enrollment period, we want to inform you of key changes to your current health plan effective January 1, 2025.

The total monthly premium for PERS Gold or Platinum will increase by Percent Increase. Please note your share may increase by a different amount due to your employer's contribution amount. Contact your employer to find out how much they contribute toward your total monthly premium.

Blue Shield of California will be the new administrator for PERS Gold or Platinum, partnering with Included Health to provide member services such as answering inquiries, assistance in finding the most appropriate high-quality providers, and providing care coordination services for members in a Basic plan, particularly those with complex health conditions. This partnership will also expand access beyond in-person care through new virtual primary care and behavioral health care services that can supplement existing in-person services when it is helpful to our members.

There are no changes to copays, coinsurance, or deductibles with this transition to Blue Shield and Included Health.

Open Enrollment is September 16 – October 11, 2024. Unless you make a health plan change during Open Enrollment, you and any dependent(s) will remain enrolled in PERS Gold or Platinum, administered by Blue Shield effective January 1, 2025.
