Government Code § 20098	CalPERS Board of Administration statutory authority to appoint and fix compensation for certain officers, investment officers and portfolio managers.
Government Code § 20099	CalPERS Board of Administration statutory authority to delegate to a committee of one or more of its members or to the executive officer.
Government Code § 20120	CalPERS Board of Administration statutory authority to manage and control the Public Employees' Retirement System.
Government Code § 20171	CalPERS Board of Administration statutory authority to administer and invest the Public Employees' Retirement Fund.

Government Code § 21661	CalPERS Board of Administration statutory authority to administer the Public Employees' Long-term Care Act.
Government Code § 21664	CalPERS Board of Administration statutory authority to administer and invest the Public Employees' Long-term Care Fund.
Government Code §§ 21670, 21677	CalPERS Board of Administration statutory authority to establish the Deferred Compensation Program and to administer and invest the Public Employees' Deferred Compensation Fund.

Government Code §§ 22200, 22201	CalPERS Board of Administration statutory authority to act as the state's Social Security Administrator.

Government Code § 22601	CalPERS Board of Administration statutory authority to use funds in the Old Age and Survivors' Insurance Revolving Fund to carry out its duties as the state's Social Security Administrator.
Government Code § 22794	CalPERS Board of Administration statutory authority to administer the Public Employees' Medical and Hospital Care Act.
Government Code § 22910	CalPERS Board of Administration statutory authority to administer and invest the Public Employees' Contingency Reserve Fund.
Government Code § 22911	CalPERS Board of Administration statutory authority to administer and invest the Public Employees' Health Care Fund.
Government Code § 22940	CalPERS Board of Administration statutory authority to administer and invest the Annuitants' Health Care Coverage Fund.
Government Code § 22970.30	CalPERS Board of Administration statutory authority to administer the Supplemental Contributions Program and to retain a third-party administrator for investment management and administrative services.
Government Code § 22970.41	CalPERS Board of Administration statutory authority to control the investment of the Supplemental Contributions Program Fund.
